We are Proud

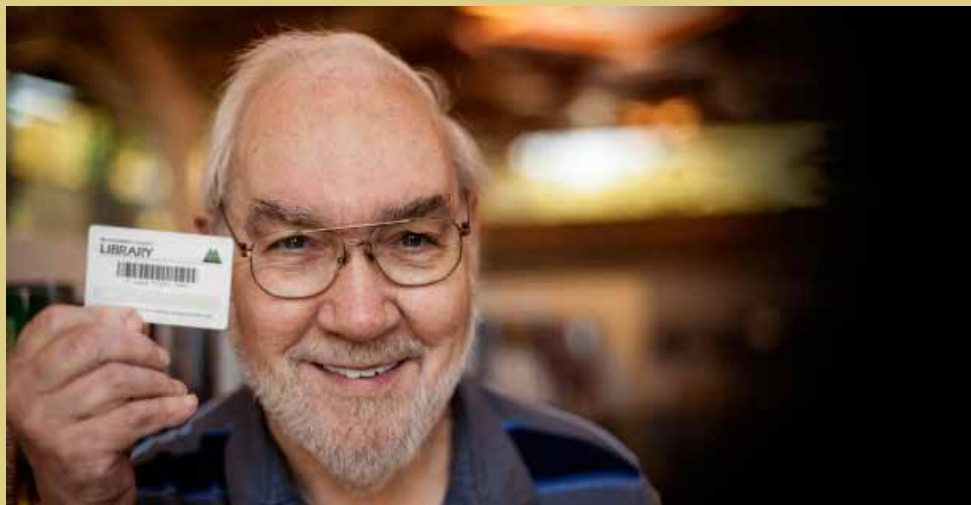
Multnomah County Library is the second-busiest library in the nation, topped only by New York Public Library.

Each morning outside our neighborhood libraries, people line up to be first inside. Bicycles and strollers surround the front doors, and lobbies resonate with the rhythmic clunk of heavily used book drops.

Inside, a profusion of programs, book browsing, borrowing and learning takes place all day long. Toddlers and parents listen to a story while seniors learn to use a computer. Teens get help with homework while adults attend financial literacy or job hunting workshops. Throughout the day, tens of thousands visit the library and converse with librarians.

The library nurtures our interests and powers our dreams. It's a vibrant gathering place and a haven for reflecting quietly amidst the company of other curious minds.

We are a community that loves our library and all it stands for. We thank all of you who gave generously of your time and resources this year. You gave from your hearts. Together we achieved remarkable things.



Every day at our library

Young readers succeed.

For many children, reading is a challenge. The library provides young readers with the tools they need to succeed. Homework help reaches more than 2,500 kids every day. Librarians and volunteers reach out to every public school in the county. They bring books and programs directly into classrooms, leveling the playing field for children of all abilities. When school is not in session, the library still is. Summer Reading broke records again this year, helping more than 110,000 children build strong reading skills.

Parents build confidence.

Parents need all the help they can get these days. The library helps parents guide their children to become successful readers. Tens of thousands of at-risk parents learn to share books with their babies and toddlers, asking questions, singing and pointing out pictures in ways that build learning-oriented brains. For families living on a shoestring, the library is a consistent, free source of educational and cultural programs. More than 140,000 people come to storytimes at their neighborhood library each year.

Seniors stay connected.

Too many seniors live without a safety net. Many are getting by on reduced incomes and may be far away from their children and grandchildren. The library helps them stay connected and engaged. Homebound seniors receive book deliveries – 160,000 each year. Traveling financial literacy classes go out to senior centers and retirement homes. The library encourages seniors to try out new technology and use it to stay connected with friends and family. And for those who prefer an old fashioned phone call, librarians are ready to answer questions anytime.

People learn and change.

We are learning new ways of living and working. Technology has changed how we formulate questions and search for answers. Digital and financial literacy have become core skills. The library helps thousands of people navigate this new world of information. Librarians and staff give one-on-one guidance. Library computers are in constant use, with people sometimes waiting more than an hour to get online. Students research a world of academic subjects, small business owners learn about new technology, immigrants study to become citizens and young adults learn how to get a GED.

We look forward.

When a librarian connects with a reader, there is a moment of exchange that no amazon.com or algorithm can ever duplicate. Librarians listen, relate, inspire and reflect along with us. This kind of exchange has been at the heart of library service for generations. And this year, we secured it for generations to come. Together we looked into the future, envisioned a strong, vibrant library system and made it a reality.

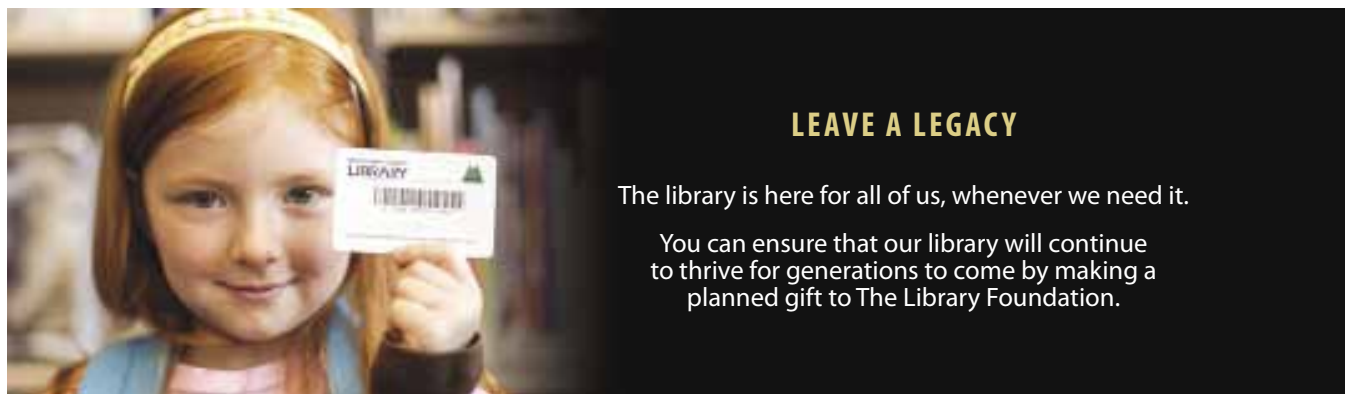

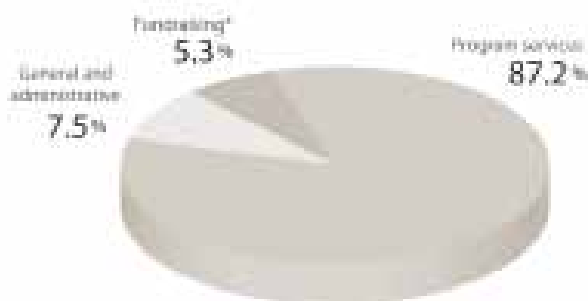

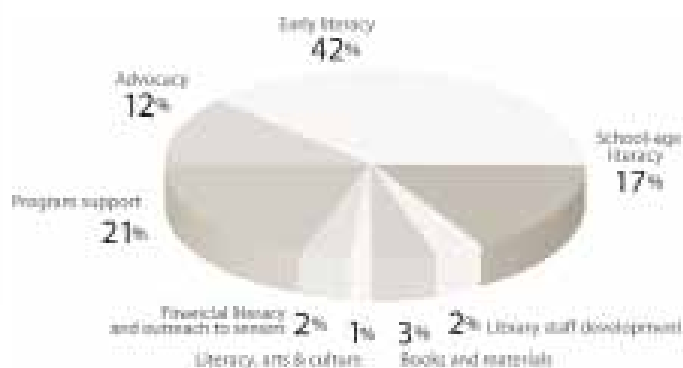
